General Instructions: The Dept. of Mathematics has completed its first round of prerequisite review for all NFYS students enrolled in math courses. This list of students is attached to the email you have received from the OSU Advisors listserv.

You will be emailed updated lists, so you can continue to check the status of your students. The Excel document includes a sheet for each campus (COL, MNS, etc.). Each sheet is then sorted by red and yellow status (as explained below). "Green" status students are no longer included in the Excel file you receive.

If you disagree with the review of a student or have questions about this process, please reach out to Math Advisor, **Caitlin Burden** (burden.45@osu.edu). She will be happy to review the enrollment with you and reach out to discuss/update the decision.

- May (TBD). Students permitted to enroll into classes based on *anticipated* 2025 AP scores only through TBD.
- **(TBD)-present**. Students cannot be waived into a math course without credit posted or written permission from Math Advising Office in OnCourse.

We are using a red, yellow, green status system to flag student enrollment status, as seen below.

Red light: Student is not permitted in class based on current student records. The student is required to either change to a different course listed under the "Required Change" column or provide additional information as indicated under the "Comment" column. Review notes about common red status issues:

1. Unknown Prereq

- The student's record does not fulfill prerequisite requirements for the MATH course they are enrolled in.
 - To remain enrolled in their current AU25 course, the student must complete one of the following:
 - Unposted transfer or test credit: Student must submit the <u>Math Prereq Verification</u> <u>Form</u>. Math Department approval of this form grants *temporary* permission to stay enrolled while they send scores/transcripts. However, if the Prereq Verification Form is not submitted and the expected credit is not posted, they will be dropped from their math course before the beginning of the term.
 - No Math Placement Test and no transfer/test credit: Student must complete the Math Placement Test and enroll based on the results.
 - Unposted standardized test score, qualifying the student for Remediation Free: See item 2 below
- 2. No Remediation Free Waiver, Incomplete Rem Free Documentation
 - Please see our <u>Quick Reference Page</u> for the documentation required to invoke the Remediation Free Policy.

• Qualifying assessment scores must be valid from *two years to the day* of 8/26/2025, the first day of AU5 semester.

Yellow light: Student is permitted to remain in their current course but is suggested to change to a different course (may be up or down a level). The suggested course of enrollment is under the "Suggested Change" column.

Green light: Student is eligible for their current course.
